

### **Topic**

## **Rules and Tips**

- 1. Each essay must include three paragraphs with a maximum of four sentences per paragraph. The first paragraph must begin with "The Magic of Union City includes...". The second paragraph must begin with "I encourage others to visit the City because...". The third paragraph must begin with "The one thing that would make the City more Magical is...".
- 2. The contest is open to all students of Union City and surrounding cities enrolled in middle and high school during the 2011-2012 school year. Students who are home schooled are eligible.
- Only one essay per student may be submitted.
- Use the City website (www.unioncityga.org) and your personal experience to guide you.
- Essays will be judged by a 5-member committee comprised of local Board and Committee members based on the following:
- Essay relation to contest topic
- Creativity
- Displayed knowledge about the City
- Legibility and proper use of grammar
- Students must NOT include any identifying information on their essay. Instead, the official entry from should be attached to the essay as a cover sheet.
- 7. Essays are due by Friday, April 20. Winners will be announced Friday, April 27. All winners will be presented at the May City Council Meeting.
- Winning essays will be included on the City's website.
