- 1. Council to consider approval of an ordinance to enact provisions pertaining to registration of vacant or foreclosed real property.

Mayor Moore led discussion and stated that adopting this ordinance was discussed at the retreat. He recommended that staff take a look at how Dekalb County is doing to administer their program although it has been litigated they have a good internal organization for their program.

Councilmember Jones asked if City of Atlanta had adopted a similar ordinance. City Attorney Davenport stated that Fulton County had; however, it was prior to adoption of provisions by the State and was not in compliance with State regulations as the proposed Union City Ordinance is.

2. Council to consider approval of a Georgia Department of Transportation (GDOT) Maintenance Highway Agreement for maintaining 5.53 miles of State Highway, including 0.09 miles of Interstate Highway.

Mayor Moore led discussion on this item and stated that the corridors which will be maintained were mentioned in the staff report. The City will be compensated \$3500 in reimbursement. Mayor Moore recommended to the City Manager that to reduce maintenance costs along the

interchange that zeroscaping be implemented and would eliminate a lot of time spent landscaping and only trash would need to be removed.

Councilmember Jones asked if the \$3,500 reimbursement will be monthly. Mayor Moore responded yes.

3. Council to consider approval of a resolution to authorize an amendment to an agreement with American Tower in order to extend the term and further amend the lease.

Mayor Moore led discussion on this item and stated that permission would be given to the City Manager to negotiate a new lease. Mayor Moore made some recommendations to the City Manager regarding negotiations in the area of co-location.
