City Attorney Davenport explained that Union City currently has a Freeport Exemption that offers businesses that qualify. He added that the 2016 General Assembly amended the Freeport Law to included e-commerce transactions which are not included in our current Freeport Exemption. He further added that Fulton County and some cities have taken it upon themselves to offer up a Freeport question on the November 8<sup>th</sup> ballot to include e-commerce Freeport in their jurisdiction and the question becomes to Union City, do we want to put the question on our ballot. City Attorney Davenport stated that in order to put the question on the ballot, everything would have to be to Fulton County on or before August 10<sup>th</sup> and if the Council decides to do so, it would necessitate a Called Meeting to adopt a resolution to call for an election to put that question on the ballot. He urged the Council to get back to him in the very near future.

At this time City Attorney Davenport stated that he needed to enter into Executive Session for two items regarding pending litigation and to review the Executive Session Minutes from June 21, 2016.
