The meeting was called to order by Mayor Williams at approximately 6:00 p.m.

1. Council to consider a contract for Probation Supervision and Rehabilitation Services.

Judge Ronald Freeman was present and made a recommendation that Union City renew the contract for Probation Supervision and Rehabilitation Services for a one (1) year term. Chief Probation Officer, Glenda Hopkins, was present as well.

2. Council to consider approval of a request to enter into a contract with Hogan Construction Group, LLC. not to exceed \$5,000,000 for the renovation and reconstruction of the old Georgia Military College (GMC) building.

3. Council to consider approval of a request to enter into a project fund agreement with BB&T in the amount of \$1,100,000 and simultaneously a supplemental lease with GMA to finance city equipment.

On motion of Councilmember Jones, seconded by Councilmember Mealing and carried, the request to enter into a project fund agreement with BB&T and simultaneously a supplemental lease with GMA was approved. Vote was unanimous.

4. Council to consider approval of a request to enter into a contract with Wamar Technologies for citywide vehicle repair and maintenance.

On motion of Councilmember Hobbs, seconded by Councilmember Nealy and carried, the request to enter into a contract with Wamar Technologies was approved. Vote was unanimous.

On motion of Councilmember Jones, seconded by Councilmember Mealing and carried, Council entered into Executive Session to discuss one item regarding pending litigation. Vote was unanimous.

On motion of Councilmember Jones, seconded by Councilmember Nealy and carried, Council reconvened to Regular Session. Vote was unanimous.

On motion of Councilmember Hobbs, seconded by Councilmember Mealing and carried, the meeting adjourned at 6:41 p.m.
