# UNION CITY REGULAR COUNCIL MINUTES

### VI. REGULAR/NEW BUSINESS:

1. Council to consider the utility adjustment request for LaShondra Lee.

On motion of Councilmember Nealy, seconded by Councilmember Jones and carried, Council agreed to adjust Ms. Lee's utility bill dating back three months. Vote was unanimously approved.

#### VII. RECOMMENDATIONS FROM THE PLANNING COMMISSION:

 Public Hearing to consider a request by Majestic Realty Co. to amend the Official Zoning Map by rezoning 97.6 acres located at 3650 Flat Shoals Road on the southeast corner of Flat Shoals Road and Buffington Road from OI & RM to the M1 Light Industrial zoning classification. Case No. RZ17-001. (On 4/18/17, this item was tabled for 30 days.) (Planning Commission Recommended Approval)

Public Hearing Closed.

On motion of Councilmember Jones, seconded by Councilmember Nealy and carried, the aforementioned item was unanimously approved. Councilmember Mealing voted in opposition of this item.

On amended motion of Councilmember Jones, and amended second by Councilmember Nealy and carried, the aforementioned item was approved with conditions and the rezoning of a Town Center Mixed Use Classification. Motion passed on a 4 to 1 vote. Councilmember Mealing voted in opposition of this item.

#### **CONDITIONS:**

- 1. Increase the size of the right turn radius and lessen the steep turn angle of the intersection for trucks coming from I-85 and turning right off of Flat Shoals Road onto Buffington Road to go southbound.
- 2. From the Flat Shoals and Buffington Roads intersection, driving south, Buffington Road would be widened from the existing two (2) lanes to three (3) lanes, which would provide:
  - A. A dedicated right turn lane down to the Oakley Industrial Blvd. connection, and a dedicated right turn lane from there to the Proctor & Gamble parking lot entrance.
  - B. A dedicated through traffic lane from the intersection all the way southbound.
  - C. A dedicated left turn lane down to the north entrance to the proposed facility, and a dedicated left turn lane from there to the south entrance to the proposed facility.
- 3. On northbound Buffington Road from approximately 300 feet south of the south entrance into the proposed facility, the following road shoulder improvements would be made:
  - A. The applicant would widen the road all the way north to the intersection.
  - B. The applicant would provide new curb, gutter and ADA sidewalks along the east side of Buffington Road to the intersection.
  - C. The applicant would provide new ADA crosswalks and ramps across and on both sides of the north and south entrances into the proposed facility.
- 4. On northbound Buffington Road from approximately 300 feet south of the south entrance into the proposed facility, the road would be widened from the existing two (2) lanes to four (4) lanes, which would provide:
  - A. A dedicated right turn lane to the south entrance into the proposed facility, and a dedicated right turn lane from there to the north entrance into the proposed facility.
  - B. A dedicated through lane all the way through the intersection to the north. People wanting to turn right onto Flat Shoals Road would turn right out of this through lane.
  - C. A dedicated left turn lane from north of the south entrance into the proposed facility to the Oakley Industrial Blvd. connection, and from that point north to the intersection, an additional second dedicated left turn lane will be added.
- On all sides of the property which abut residentially zoned properties, the required 75 foot wide landscape screen buffer would be further enhanced to provide the opacity equivalent to a solid wall for sound and sight screening.
