# CITY OF UNION CITY REGULAR COUNCIL MEETING MINUTES

#### VI. REGULAR/NEW BUSINESS:

A. Council to consider approval of a resolution to abandon a section of the municipal street system that has ceased to be used by the public (0.49956-acre, parcel of land that is currently or formerly known as Scarborough Road).

The portion of Scarborough Road, as shown on the referenced plat has ceased to be used by the public to the extent that no substantial purpose is served by it and as such, its removal from the municipal street system is in the best interest of the public.

On motion of Councilmember Nealy; seconded by Councilmember Mealing and carried, Council declared that a section of Scarborough Road, as shown on the plat, be abandoned. Councilmember Jones opposed. Vote was 3 to 1.

B. Council to consider approval of a resolution for the conveyance of certain real property to Southern Parkway, Inc., in order to dispose of property that has been abandoned from the municipal road system by the City of Union City (roadbed formerly known as Scarborough Road).

Assistant Attorney Stough advised Council that an Opinion of Value was received from the appraiser in the amount of \$4,500.00.

On motion of Councilmember Nealy; seconded by Councilmember Mealing and carried, Council approved the resolution for the conveyance of certain real property to Southern Parkway, Inc. Councilmember Jones opposed. Vote was 3 to 1.

#### VII. RECOMMENDATIONS FROM THE PLANNING COMMISSION:

A. **Public Hearing** to consider the rezoning request (PDC Atlanta, LLC) to rezone 101.79 acres of land at the intersection of South Fulton Parkway and Highway 92 from General Commercial to Town Center Mixed Use.

PDC Atlanta, LLC submitted a letter requesting Council to defer the Public Hearing until June 19, 2018, in order to work on alternatives. Mayor Williams read the letter (during the Work Session) that he received from the petitioner requesting additional time to further explore the feedback received as it relates to the size of the building and the desire for additional restaurant, and/or retail uses on the property.

On motion of Councilmember Mealing; seconded by Councilmember Hobbs and carried, Council agreed to table the item till June 19, 2018. Vote was unanimous.

B. **Public Hearing** to consider the request of a stream buffer variance in regard to a proposal to develop a 350,000 sq. ft. logistical warehouse on Goodson Road. (Staff Recommends Approval)

Councilmember Nealy asked whether the proposed development will cover the spring head. The petitioner, Adam Richards of Reliance Real Estate Partners, stated that it will not.

Councilmember Mealing requested a copy of the mitigation plan. Director Still will give Council a copy.

On motion of Councilmember Nealy; seconded by Councilmember Mealing and carried, Council approved the request of a stream buffer variance in regard to a proposal to develop a 350,000 sq. ft. logistical warehouse on Goodson Road. Councilmember Jones opposed. Vote 3 to 1.

The following conditions to encroach within the 25-foot buffer adjacent to State waters, as required by the Georgia Department of Natural Resources Environmental Protection Division, will be met:

- 1. All graded slopes 3:1 or greater will be hydroseeded and covered with Georgia DOT approved wood fiber matting or coconut fiber matting. If not hydroseeded, Georgia DOT approved matting that has been incorporated with seed and fertilizer will be used. All slopes will be properly protected until a permanent vegetative stand is established.
- 2. The amount of land cleared during construction will be kept to a minimum.

- 3. All disturbed areas will be seeded, fertilized and mulched as soon as the final grade is achieved. Also, these disturbed areas will be protected until permanent vegetation is established.
- 4. A double row of Georgia DOT type "C" silt fence or an approved high performance silt fence will be installed between the land disturbing activities and State waters where appropriate.
- 5. Buffer variance conditions will be incorporated into any Land Disturbance Activity Permit issued by Union City for this project.
- 6. The project will be conducted in strict adherence to the approved erosion and sedimentation control plan and any Land Disturbing Activity Permit issued by Union City.
- 7. Post-construction stormwater management system (i.e., micropool extended detention pond and a CrystalStream Technologies (CST) CrystalClean separator) will be maintained to ensure pollutant removal efficiencies for water quality protection.

### VIII. <u>CITY MANAGER'S REPORT</u>:

#### A. Animal Control Services:

City Manager Fillingame shared with Council that Fulton County did a RFP (Request for Proposal) for Animal Control Service. The options were "Baseline Level of Services" or "Best in Class". The consensus received was for Baseline Services. Fulton County provided estimated costs for services in the amount of \$192,391.00. City Manager Fillingame spoke with Todd Long, Chief Operating Officer last week and there may be an extended agreement as Fulton County continue to sort through this. Last year Union City spent \$107,589.00.

Mayor Williams advised that he will be meeting with all of the Mayors of Fulton County and the Board of Commissioners to discuss the Animal Control Service issue.

#### B. Website Update:

City Manager Fillingame thanked Trey Bennings (IT Manager) for providing assistance prior to fulfilling the Marketing Specialist position. City Manager Fillingame introduced Tristan Crum as Union City's Marketing Specialist and extended congratulatory remarks to Mr. Crum for doing an excellent job.

Mr. Crum briefed Council on his approach to updating the website and shared a Powerpoint presentation on four different design layouts. He stated that his goal was "to make sure that the website and brand created would exemplify who we are in Union City". Each design focused on a color scheme that represented wisdom, creativity, and productivity. He requested Council's feedback and the consensus received was for design #1. Mayor Williams asked Mr. Crum to share the design layouts with the community on April 30, 2018 at the Town Hall Meeting.

Director Still introduced Mr. Kalanos Johnson as Union City's Senior Planner. Mr. Johnson has a Master's Degree in Planning and looks forward to working in Economic Development, CID's and Planning.
