- Grady Health System-EMS Presentation Dr. Shara Mayberry and Dr. Steven Moyers

Dr. Steven Moyers, Vice President and Dean of Education for Grady Health Systems-Grady EMS introduced his colleagues: John Hanson - Vice President of Administrative Services, Dr. Shara Mayberry - Nurse Administrator and Nurse Practitioner of their Mobile Integrated Health Program (MIH), and Dr. Author Yancey - Medical Director whom serves as the Chief Medical Officer.

Dr. Moyers advised Mayor, Council, and the Citizens on how Grady EMS operates and responds within the Grady Health System. Dr. Moyers stated that they are very appreciative of their partnership within the South Fulton Community. Grady EMS has been in the area (Oakley Industrial Blvd.) for nine (9) months and running an average of 500 plus calls per month (from an emergency call standpoint). Dr. Moyers stated that they have been working closely with Fire Chief Maddox and his team.

Dr. Yancey shared Grady Health System's ideas and implementations on how to better serve the citizens of Union City. Dr. Yancey advised that he has been working directly with Fulton County 911 on a monthly basis and that they are almost done with the CAD Integrations (Computer Aid Dispatch). The integration should be completed around April 30, 2019.

Dr. Mayberry spoke about Grady's Mobile Integrated Health Program. Dr. Mayberry stated that "this is an innovative way to expand the services offered by traditional EMS services and then bring care to the community by addressing individual needs." The MIH Program will bring health services to the community.

Dr. Mayberry spoke regarding the 911 System. She indicated that once the CAD to CAD is in place, Grady Health Systems will be able to dispatch their mobile care team which comprise of a Nurse Practitioner, and an Advanced EMT or Paramedic. They would go to an individual's home and assess the situation by providing a clinical assessment, evaluate the social and environmental factors that impact the patient's health, and connect them with the appropriate community resource to address the needs. She stated that often times, people will call 911 for non-emergency complaints which takes away from the overall EMS System and from being able to respond to true emergencies. Dr. Mayberry also stated that by implementing the mobile care team, it will be able to reduce the amount of ALS and BLS ambulance that have to respond to those calls by providing them with a Nurse Practitioner, EMT or Paramedic that can address those concerns.

Dr. Mayberry stated that the MIH Program will help reduce the burden on the overall 911 System and the emergency rooms. The MIH Program will also connect patients with the appropriate level of care, and improve the overall quality of life for members in the community. Lastly, she stated that Grady EMS looks forward to working with Union City in accomplishing their goals.

 Kipp Carr (Hilliard Starkey Law Firm) – Mr. Carr provided Mayor and Council with a brief legislative update.
