On motion of Councilmember Jones, seconded by Councilmember Hobbs and carried, the Consent Agenda was unanimously approved.

V. RECOMMENDATIONS FROM THE PLANNING COMMISSION:

- A. **Public Hearing** to consider a request for approval to rezone 2.25 acres of land at 5445 and 5455 Stonewall Tell Road from R-1 Single Family Residential to TCMU Town Center Mixed Use. (Stonewall Station Rezoning)

Director Still led the discussion. He stated the request was part of a larger subdivision consisting of the subject properties and other properties currently zoned TCMU.

Petitioner, Chris Doughtie (P.O. Box 856, Duluth, GA 30096) spoke in favor of the request and mentioned he had been developing in the area and would match what was in the area. He advised Mayor and Council that homes on the east side of Stonewall Tell would range \$180,000.00 - \$205,000.00. Homes on the west side would range \$210,000.00 - \$240,000.00.

Public Hearing Open

Rebuttal by Petitioner, Chris Doughtie

Public Hearing Closed

On motion of Mayor Pro Tem Mealing, seconded by Councilmember Hobbs and carried, Council approved the above mentioned rezoning. Vote was unanimous.

- B. **Public Hearing** to consider a request to amend the Official Zoning Map for rezoning of 101.79 acres located at the intersection of South Fulton Parkway and Highway 92 from General Commercial (GC) to Town Center Mixed Use (TCMU). (Southpoint Farms LPIV, LLC)

Director Still led the discussion and Attorney Laura Henderson spoke regarding the below four (4) conditions that were amended.

1. The applicant shall set aside 1.5 acres for a park and parking lot for access to the trail area that will be dedicated to the City.
2. The applicant shall maintain an undisturbed 75 foot buffer along the frontages of the property and to berm and plant areas where the buffer cannot maintain the 75 foot buffer.
3. The applicant shall comply with the site plan dated August 2, 2019 in development of the property. This site plan includes a 4.2 acre parcel for commercial/office along Campbellton-Fairburn Road and an additional 37.8 acres reserved for commercial development.
4. The applicant shall screen the rear of the building where necessary.

Attorney Henderson stated “should Mayor and Council decide to approve the rezoning, we would ask you to specifically attach those and any other conditions you find appropriate.”

Petitioner G. Doug Dillard, Esquire (Dillard Sellers Attorneys at Law, 1776 Peachtree Street, Suite 322S, N., Atlanta, GA 30309) spoke on behalf of the applicant. He distributed copies of the PowerPoint Presentation and the August 2, 2019 Site Plan.

Attorney Dillard mentioned the original site plan submitted on the amendment was dated July 26, 2019. He stated the difference between July 26th site plan and August 2nd site plan was that the August 2nd site plan did not show access to South Fulton Parkway. Also, he mentioned that he agreed with the recommendations made by Director Still and Attorney Henderson. He introduced Dayne Pryor and asked him to share a PowerPoint Presentation.

Dayne Pryor, local partner of Panattoni Development (9040 Roswell Road, Suite 420, Atlanta, GA 30350) stated that he represented Southpoint Farms, LLC. He shared a PowerPoint Presentation with Mayor and Council and advised that he purchased the property last year.

Mr. Pryor noted the project was a true mixed use to match with the TCMU Zoning. He also mentioned significant adjustments were made.

Rebuttal by Petitioner, Attorney Dillard

Public Hearing Closed

On motion of Councilmember Hobbs, seconded by Councilmember Nealy and carried, the request to amend the Official Zoning Map mentioned above was approved with conditions. Vote was unanimous.

- C. **Public Hearing** to consider a request for approval of a text amendment to revise the TCMU Zoning District.

Director Still led the discussion. He stated the document was quite lengthy and there were a number of recommendations from the Planning Commission and the Stakeholders.

Woody Galloway (Galloway Law Group) – Spoke in support of the Planning Commission’s recommendation with one change. He stated the Planning Commission required that there be more than one use within the TCMU District. He said additionally, it is problematic to have “multiple uses” and most apartment developers, single family developers, and office developers prefer “one use”. He further stated that he supported the change without changing it to “multiple uses”.

Mayor spoke regarding the challenges of TCMU and the impact to Union City residents.

Attorney Davenport advised Mayor and Council that a 90 Day Temporary Moratorium can be put in place to allow the City time to determine whether or not industrial should remain within TCMU. No new applications would be accepted for TCMU during the 90 day period. He stated several step would apply should Mayor and Council decide to move forward. The steps would include advertisements, Public Hearings, etc.

On motion of Mayor Pro Tem Mealing, seconded by Councilmember Hobbs and carried, an emergency 90 Day Temporary Moratorium was approved. Vote was unanimous.




