Ms. Alexander thanked Mayor and Council for allowing The Collaborative Firm to assist with analyzing Union City's Town Center Mixed Use District (TCMU). She provided a brief chronology order regarding the history of TCMU. and her approach to reviewing TCMU. Also, she stated her approach to reviewing TCMU and that her primary concern was for South Fulton Parkway. The following items were discussed:

- Scope and Impact of any changes
- Existing Conditions and Options
- Adopted Policy and Comprehensive Plan
- Recommendations and Discussed language possible for adoption

Mayor and Council told Ms. Alexander that she had done a phenomenal job with the short timeframe she was given to work on the project. Councilmember Mealing requested a copy of the presentation.

All matters listed on the Consent Agenda are considered routine by the Council and will be approved by one motion. No separate discussion will take place on these items. If discussion of any Consent Agenda item is desired, the item will be moved to the Regular Agenda for separate consideration.

V. OLD BUSINESS:

A. Council to discuss current residential (Waste Industries) and commercial (Advanced Disposal) sanitation agreements.

Assistant City Manager Calloway requested a 60 day extension. She stated the final negotiations are close to being settled.

On motion of Councilmember Jones, seconded by Councilmember Hobbs and carried, Council agreed to extend the negotiations for 60 days. Vote was unanimous.

B. Council to consider a request for approval of a text amendment to revise the TCMU Zoning District. PLANNING COMMISSION AND STAFF RECOMMENDED APPROVAL.

On motion of Councilmember Jones, seconded by Mayor Pro Tem Nealy and carried, Council agreed to go with the recommendations of The Collaborative Firm, post the revisions of the TCMU ordinance on the website by February 10, 2020, and advertise the Public Hearing for February 18, 2020 Council Meeting. Vote was unanimous.

On motion of Councilmember Jones, seconded by Councilmember Mealing and carried, Council agreed to extend the TCMU Moratorium until February 18, 2020. Vote was unanimous.

C. Council to consider the "Removal of Industrial Uses" from the Town Center Mixed Use Zoning District. The issue was remanded back to the Planning Commission for consideration per 09/17/19 Council Meeting. PLANNING COMMISSION AND STAFF RECOMMENDED REMOVAL OF INDUSTRIAL USES. (The item was tabled until January 21, 2020.)

City Attorney Davenport said the motion made for item "B" encompass item "C" and that the emergency moratoriums over-ride the tabled items.

On motion of Councilmember Jones, seconded by Councilmember Mealing and carried, Council agreed to extend the TCMU Moratorium until February 18, 2020. Vote was unanimous.

VI. REGULAR NEW BUSINESS:

A. Council to consider the reappointment of the City Attorney, Dennis Davenport (Law Firm of McNally, Fox, Grant & Davenport).

On motion of Councilmember Hobbs, seconded by Councilmember Jones and carried, Council reappointed Attorney Dennis Davenport as the City Attorney. Vote was unanimous.

B. Council to consider the reappointment of the City Clerk, Shandrella Jewett.

E. Council to consider the reappointment of the Police Chief, Cassandra Jones.

Attorney Davenport advised Mayor and Council the packet indicates a packaged license. He was not sure if that included beer and wine. He further stated if it is on-premises, it would have to be both (beer, wine, and spirituous). He stated he would go back and review the packaged license. He requested the item be tabled.

VIII. CITY MANAGER'S REPORT:

 - The Governor's Office of Highway Safety Grant

Nydia Akins (Union City's Grant Specialist) provided an update regarding the Federal Grant funded by the National Highway Traffic Safety Administration. The purpose of the grant is to promote the development of the Traffic Enforcement Program which helps reduce precious injuries and fatalities in the community. The City can request up to \$300,000.00 and no match is required. Two officers will be needed to run a successful program should the City receive the award. The application deadline is February 21, 2020 and the matter will be brought back before Mayor and Council for final approval.

The Georgia Firefighter Standards and Training Council Fireworks Tax Grant

Ms. Akins provided a brief updated regarding the grant. The grant is funded from the fireworks tax sales. The maximum award amount is \$25,000.00, and requires a 10% match of \$2,500.00. Fire Chief Maddox requested four new portable radios, which costs \$5000.00 each. The application deadline is February 21, 2020.
