**I. NEW BUSINESS:**

1. Council to approve and adopt Resolution 2020-07 to provide Emergency Leave to Employees during Government Declared Public Health State of Emergency.

2. Council to approve an amendment to the Employee Handbook that will provide Emergency Leave to Employees during Government Declared Public Health State of Emergency.

3. Council to consider and approve acceptance of property donation (Derrick Road, OSCP2, LLC) from The Institute for Education Advancement, Inc.

*On motion of Councilmember Jones, seconded by Councilmember Mealing and carried, Council agreed to accept the donation of property located on Derrick Road. Vote was unanimous.*

4. Council to approve a Memorandum of Understanding with the City of Fairburn, Georgia for the use of their E-Warrant System.

*On motion of Councilmember Mealing, seconded by Councilmember Hobbs and carried, Council approved the Memorandum of Understanding with an amendment giving Police Chief, Cassandra Jones, authorization to sign the agreement. Vote was unanimous.*

5. Council to approve a Declaration of a state of Local Emergency for Union City.

*On motion of Councilmember Jones, seconded by Mayor Pro Tem Nealy and carried, Council agreed to approve Union City's Declaration for a Local State of Emergency. Vote was unanimous.*

6. Council to approve (at minimum) \$100,000.00 for additional resources to assist the community in the event of an emergency situation.

*On motion of Councilmember Jones, seconded by Mayor Pro Tem Nealy and carried, Council agreed to approve, at minimum, \$100,000.00 for emergency response. Vote was unanimous.*


7. Council to approve extending the VC3 contract for an additional year.


