The meeting was called to order at 9:12 a.m.

Mayor Pro Tem Nealy joined the meeting at 10:03 a.m.

#### I. CONSENT AGENDA:

All matters listed on the Consent Agenda are considered routine by the Council and will be approved by one motion. No separate discussion will take place on these items.

- A. Council to approve a request to enter into an Intergovernmental Agreement between the City of South Fulton and Union City for the resurfacing of Hunter Road in the amount of \$317,660.23.
- B. Council to approve and adopt a Conveyor Car Washes Ordinance to reduce water consumption from commercial car wash facilities by requiring all new conveyor car washes to install operational recycled water systems.
- C. Council to approve a request to adopt a Large Landscape Irrigation Systems Ordinance to reduce water waste and water loss for systems greater than one acre.
- D. Council to approve a request to adopt a Factory Mutual Fire Line Meters Ordinance that requires commercial buildings or properties that has fire hydrants or hydrants attached to them on private property install a factory mutual fire line meter.
- E. Council to approve a request to adopt a resolution to authorize changes to the City's Georgia Fund 1 investment account.
- F. Council to approve a request to adopt a resolution to enter into an agreement (#P20AP00168/13-01025) with the Georgia Department of Natural Resources under the Land and Water Conservation Fund; The agreement provides grant assistance for the development of a skate park at the Highway 29 Ballfields.

Nydia Akins (Grant Specialist) reminded Mayor and Council of their favorable responses to move forward with the initial application of the grant back in October 2018. She advised the City recently received a successful award from the Georgia Department of Natural Resources which would be for outdoor recreational use only. Mayor Williams reiterated that should the City accept the award, Highway 29 Ballfields must always remain a park and recreation area per the grant requirements.

G. Council to approve a request to enter an agreement with C.W. Matthews Contracting Company to complete the Citywide Resurfacing Project.

- H. Council to approve a grant award (2020-VD-BX-0237) in the amount of \$61,188 through the U.S. Department of Justice Bureau of Justice Assistance 2020 Coronavirus Emergency Supplemental Funding Program.
- I. Council to approve a request to adopt a resolution titled NLC Cities Are Essential.

On motion of Councilmember Hobbs, seconded by Councilmember Jones and carried, Council approved the Consent Agenda. Vote was unanimous.

On motion of Councilmember Mealing, seconded by Councilmember Jones and carried, Council agreed to move forward with the residential (GFL Environmental, Inc.) and commercial (Advanced Disposal) sanitation agreements. Vote was unanimous.

C. Council to discuss and approve a renewed contract (four year term effective April 17, 2020) with the City Manager of Union City.

On motion of Councilmember Hobbs, seconded by Councilmember Mealing and carried, Council approved the four (4) year contract of City Manager, Sonja Fillingame. Vote was unanimous.

A. Assistance to Firefighter Grant FY 2020 COVID-19 Supplemental Program

Nydia Akins (Grant Specialist) advised Mayor and Council that the Fire Department submitted an application for FY 2020 Assistance to Firefighter Grant (COVID-19 Supplement Program). There is a 5% city cost share in the amount of \$631.25 and a federal share of \$12,625.00. The total is \$13,256.25. The grant would be used for the purchase of Half Mask Respirators, Respirator Cartridges and Filters, Anti-Fog Safety Goggles, and Isolation Gowns.

Also, Ms. Akins advised Mayor and Council should the City receive the award, the City will come back for formal approval.

Director Warren spoke regarding a voluntary shared leave program and legal concerns. Mayor and Council shared their thoughts concerning the program and reiterated that it would be a voluntary anonymous program.

Assistant City Manager Calloway and Attorney Davenport spoke regarding tax implications. Attorney Davenport expressed complications that could arise in smaller organization as well. Chief Maddox mentioned there was a shared leave program in the past. Mayor Williams stated the matter should be discussed at a budget hearing and for the City Manager and the City Attorney to have dialogue concerning the matter.

Assistant City Manager Calloway asked Mayor and Council for directions as to how to move forward with Performance Evaluations and Increases. Mayor Williams said this matter will be discussed later to ensure the City make the right decision. Council agreed as well.
