The meeting was called to order at 9:04 a.m.

I. CONSENT AGENDA:

All matters listed on the Consent Agenda are considered routine by the Council and will be approved by one motion. No separate discussion will take place on these items.

- A. Council to approve a request to adopt a resolution for acquisition of 0.93 acres of property located at 6405 Roosevelt Highway" (Land Lot 77 in the 9F District of Fulton County, \$86K) from Mr. Clay R. Neisler.
- B. Council to approve a request to adopt a resolution for acquisition of approximately 1.0803 acres of property located at 0 Roosevelt Highway; 6429 Roosevelt Highway; and 6425 Roosevelt Highway (Land Lot 77 in the 9F District of Fulton County, \$144K) from Ms. Ruth R. Neisler.

On motion of Mayor Pro Tem Nealy, seconded by Councilmember Mealing and carried, Council agreed that all flags fly at half-staff. Vote unanimous.

- C. Interim Assistant Chief of Police (Gloria Hodgson) Pay Status Update provided by Director Warren

Mayor William asked for an update on the status of the new Interim Assistant Chief of Police (Gloria Hodgson). City Manager Fillingame stated she would discuss this matter with Police Chief Jones and HR Director, Linda Warren.

D. Council to approve a request to add Juneteenth as a paid holiday for Union City staff.

Mayor Williams asked Assistant City Manager Calloway if she had an update on information concerning Juneteenth becoming a holiday in Union City. ACM Calloway responded that it would be a paid holiday (straight pay) for staff with no overtime.

On motion of Councilmember Mealing, seconded by Councilmember Hobbs and carried, Council agreed to add Juneteenth as a paid holiday for Union City staff. Vote was unanimous.

E. Union City Reopening Update

Mayor Williams said the Senior Leadership Team has prepared a "Phase Plan" for when the City reopens. However, the matter will be revisited at a later.

F. Council to approve a request for hazardous pay to start back up for period July 21, 2020 to August 31, 2020.

Mayor Williams said the previous hazardous pay ended on June 20, 2020. He spoke about reestablishing the hazardous pay for July 21, 2020 to August 31, 2020. There will not be any retroactive pay and the pay rate will remain the same.

On motion of Councilmember Jones, seconded by Councilmember Hobbs and carried, Council approved hazardous pay for period July 21, 2020 to August 31, 2020. Vote was unanimous.

G. Council to approve a request to demolish and rebuild the Kenneth L. Johnson Depot building along with keeping as much historical artifacts as possible.

Director Ferguson provided an update regarding the available two options received from the contractors.

Option 1 - Repair the existing building and keep as much of the historical materials as possible. The walls and floors would need to be replaced. The roof is the only historical item that could be saved.

Option 2 - Demolish the entire building and start from scratch.

On motion of Councilmember Jones, seconded by Councilmember Mealing and carried, Council agreed to move forward with Option 2 and keep as much of the historical aesthetics as possible. Vote unanimous.

H. Court Services Update

Director Collier advised Mayor and Council that Court Services was scheduled to reopen on August 3, 2020. However, the City will still be closed. Court Services will push back the reopening date and will notify everyone via letters and on the website.

I. Highway 29 Ballfield Update

City Manager Fillingame, Director Blitch, and Director Ferguson provided an update regarding the score box being completed by Friday, July 24, 2020, and the entire project being completed within the next three weeks.
