Work to determine realistic guidelines to implement the goals and incorporate citizen input into the city plan.








## **POPULATION CHANGE**




Between 2010 and 2018, Union City's racial makeup experienced a few notable changes.

The proportion of black residents increased by about 6% while the white population remained relatively constant. The proportion of residents identifying as either Asian or "some other race" both fell between 2010 and 2018.

7.5% of residents of any race identified as Latino in 2010, and this percentage decreased to 3.6% by 2018.

Union City's racial composition is quite similar to that of the 10-county metro area as a whole.


The Atlanta region is roughly 9.6% Hispanic, while Union City's population is roughly 3.6% Hispanic.



#### 10-County Atlanta Metro Tenure





## **HOUSING TYPES**




Union City is experiencing a moderate shift in the composition of its housing stock. While the city has gained roughly 1,100 dwelling units, that growth has been concentrated in single-family homes. Simultaneously, the proportion and count of multi-family homes have decreased.

Due to the sample size and quality of data, these figures should be considered rough estimates.


## MEDIAN HOUSEHOLD INCOME






# What jobs exist within Union City?



# Development Patterns: Needs and Opportunities

#### Needs

- Aging neighborhoods and multi-unit housing
- Inter-parcel connectivity and access management along corridors
- Multi-model transportation-expand MARTA
  - Example-Roosevelt Highway or Pedestrian street activity very low to non-existent

### Opportunities

- Historic Downtown/Union Street
- Improving connections between downtown and Hwy 138/Jonesboro Road Corridor
- Capacity for growth along South Fulton Parkway corridor
- Existing South Fulton Parkway corridor zoning
- Enhanced pedestrian infrastructure along Shannon Parkway



## Social and Economic Development: Needs and Opportunities

### Needs

- Dependence on retail trade
  - Bedroom community
- Housing and employment mismatch

### Opportunities

- First Opportunity Zone in Metro Atlanta designated in Union City
- Foreign Trade Zone/Freeport Tax
- Growing economic base/Diverse employment


## 2019 MASTER PLAN/Vision for Comprehensive Plan

Vision: Union City will have walkable mixed-use development connected to parks and downtown areas with safe crossings, lighting, and a convenient public transportation system. The city will feature a variety of restaurants, retail, and educational opportunities with a strong tourism and technology business complete with Class A office space. Union City will have a thriving environment with venues and gyms promoting a safe place to play, live, and work.

## Work Plan

Not Completed-

- Work with organizations such as PEDS to coordinate safe routes to school programs and PATH for and pedestrian connections.
- Review and amend tree preservation regulations
- Adopt development regulation amendments requiring installation of bicycle and pedestrian amenities with new development.
- Utilize conservation easements and other land preservation tools
- Create a new bicycle and pedestrian friendly roadway corridor that connects the Downtown/City Hall area to Shannon Parkway (as described in the Union City Town Center LCI Study recommendation)
- Work with organizations such as PATH or Georgia Bikes for bicycle connections.



## Work Plan

### Not Completed-

- Adopt street connectivity standards that require connectivity within new development and to adjacent areas
- Nominate eligible properties to the National Register of Historic Places and promote the City's history
- Develop incentives that encourage diverse and affordable housing
- Review and amend park and open space dedication requirements and incentives
- Identify corporate partners with community development programs that may help with beautification/maintenance costs of existing parks
- Utilize the upcoming South Fulton Parkway Corridor Plan process to continue coordinated planning with adjacent jurisdictions and to ensure the balanced development of South Fulton Parkway.
- Implement the recommendations from South Fulton Parkway Corridor Plan. This may include, transportation projects, changes to land use policy and changes to zoning regulations.



## Work Plan

#### ADDED-

- Coordinate with Marta on the Greenway Model Mile project on Royal South Parkway including the use of the Park-N-Ride for a trailhead for a greenway path from Feldwood Road to Buffington Road.
- Coordinate with Marta to restore routes along Roosevelt Highway.
- Coordination with the Aerotropolis Atlanta Alliance.
- Investigate park/gathering spaces in underserved areas.
- Pursue discussions about the revitalization and redevelopment of Dixie Lakes.
- Pursue emergency facilities and technology colleges.
