#### VI. OLD BUSINESS:

A. Council to approve the submittal of a request to enter into an agreement with Fulton County Board of Registration and Elections to conduct Union City's November 2, 2021 Municipal General Election. (The item was tabled for 30 days per the May 2021 Council Meeting.)

On motion of Councilmember Jones, seconded by Councilmember Mealing and carried, Council approved the agreement with Fulton County Board of Registration and Elections Office to conduct Union City's 2021 Municipal General Election. Vote was unanimous.

#### VII. CONSENT AGENDA:

All matters listed on the Consent Agenda are considered to be routine and will be approved by one motion. No separate discussion will take place on these items. If discussion of any Consent Agenda item is desired, the item will be moved to the Regular Agenda for separate consideration.

- B. Council to approve the Regular Council Minutes dated May 18, 2021.
- C. Council to approve the submittal of a request to accept donated property from BOC Acquisition 1, LLC. The property is located at 6760 Buffington Road, 6750 Buffington Road, and 0 Buffington Road. The parcels (totaling 13.25 acres and fronting on Buffington Road) will be restricted for use as a park or recreation (greenspace).
- D. Council to approve the submittal of a request to enter into an agreement with Stewart Brothers, Inc. to complete the resurfacing of College Street, Baker Street, and Alexander Street.
- E. Council to approve the submittal of a request to enter into an agreement with the Criminal Justice Coordinating Council (CJCC) for the FY 2021 Law Enforcement Training Program (Subgrant # K75-8-050). The subgrant award will help purchase the MILO Interactive Mobile-Situational Awareness Training Simulator.
- F. Council to approve the submittal of a request to update the City Ordinance regarding water bill disputes.
- G. Council to approve the submittal of a request to adopt TSPLOST 2022-2027 project list.

On motion of Councilmember Mealing, seconded by Councilmember Nealy and carried, Council approved the Consent Agenda during the Work Session. Vote was unanimous.

#### VIII. NEW BUSINESS:

A. Council to approve the submittal of a request to adopt a resolution abandoning a portion of roadbed known as Scarborough Road. The property runs between South Fulton Parkway and parcel 09F340101340359.

The City having determined that a section of the City road system has ceased to be used by the public to the extent that no substantial public purpose is served by it and that its removal from the City road system is otherwise in the best public interest. On motion of Councilmember Jones, seconded by Mayor Pro Tem Hobbs and carried, Council agreed to abandon that section from the City street system. Vote was unanimous.

B. Council to approve the submittal of a request to adopt a resolution selling and conveying a parcel (formerly known as Scarborough Road) to the abutting property owner, Southern Parkway, Inc.

The City abandoned a section of the City road system known as Scarborough Road. On motion of Councilmember Jones, seconded by Mayor Pro Tem Hobbs and carried, Council agreed to convey said abandoned road section to the abutting property owner, Southern Parkway, Inc. Vote was unanimous.

C. Council to approve the submittal of a request to accept a Change Order (budget increase), in the amount of \$90,391.62, for the Kenneth L. Johnson Depot renovations.

On motion of Councilmember Mealing, seconded by Councilmember Jones and carried, Council approved a budget increase in the amount of \$90,391.62. Vote was unanimous.

D. Council to approve the submittal of a request to accept a Change Order (budget increase), in the amount of \$21,262.71, for the Public Services building and Fire Station Headquarters #42 renovations.

On motion of Councilmember Nealy, seconded by Mayor Pro Tem Hobbs and carried, Council approved the request to transfer money from the Contingency Fund to the Capital Project Fund to cover the additional costs (\$21,262.71) of both above mentioned renovations. Vote was unanimous.

A. A **Public Hearing** for Council to consider a request for a variance from the 25-foot stream buffer for parcel number 09F-3201-0146-009-2 located at the intersection of Derrick Road and Derrick Industrial Parkway (at or near 4775 Derrick Road), Union City, for a distance of 376 feet. (Staff Recommends Approval with Conditions)

B. A **Public Hearing** for Council to approve a request for a variance from the 25-foot stream buffer for parcel number 09F-3201-0146-028-2 located at the intersection of Derrick Road and Derrick

Industrial Parkway (at or near 4775 Derrick Road), Union City, for a distance of 173 feet. (Staff Recommends Approval with Conditions)

On motion of Councilmember Jones, seconded by Mayor Pro Tem Hobbs and carried, Council tabled the above request for 30 days. Vote was unanimous.
