New Business: A. Item #19000068 - A request to extend the Preliminary Plat for Deerhaven Subdivision. The land consists of 155.06 acres zoned RMD-1 (Single Family Residential) and is proposed to construct 345 lots. This plat was approved with Condition in September 30, 2019.

Director Ellis Still stated this subdivision was approved by the Planning Commission in 2019. After 12 months the plat expired. The applicant is asking to extend the Preliminary plat without going through the process again. There is conditional approval with the plat. Property to the rear across the creek would have recorded access plat to get to the property so that it would not be land locked. That was the condition. Staff recommends approval with that condition.

Member Trevor Cason ask if 345 Single family units would reduce the parcels from 6 to 4.

Wade Stroud (Applicant) stated the density has not changed. They are still following the same lot configuration.

Attorney Patrick Stough states that when the plat was 1<sup>st</sup> submitted, it included 2 parcels that were in the city of South Fulton. They resubmitted with those removed.

Chairwoman Marilyn McCain asks about a legal issue that Director Still mentioned. There is a recording of the access easement to the rear parcel that will be noted on the preliminary plat. Has it been received?

Director Ellis Still stated that we have not received a new plat.

Chairwoman Marilyn McCain stated that it must be noted on the Preliminary Plat. Chairwoman also recommends to mayor and council.

Director Ellis Still states it will not go to council. Preliminary plat goes the Planning commission for approval.

Chairwoman Marilyn McCain asks if there is any future business.

Director Ellis Still states that new business for next month is a single family subdivision off of Hwy 138 and Edison close to Union Point that will be coming before the commission next month.

Chairwoman Marilyn McCain asks if the meeting will be virtual next month.
