

IV. New Business:

A. Item #21000070 – A request by OneStreet Residential, LLC for property located at 6822 Shannon Parkway to reduction the amount of required parking from 2 parking spaces per unit to 1.25 parking spaces per unit. This request is a proposed reduction of 0.75%. (Public Hearing)

Director Ellis Still presented the Site Plan below.



Director Ellis Still stated the property is zoned GC and the petitioner is requesting a Variance to change the zone to TCMU. The lot is vacant.

Director Still states the staff has recommended approval of the Variance for a Senior Living Community.

Chair Robert Potts asked about the reduction of 2 to 1.25 spaces. Chair Robert Potts opened the meeting up to the public.

Petitioner / Attorney Kathy Zickert, 33100 Peachtree Atlanta representing OneStreet for over 20 years stated that Onestreet has secured over 8500 units for age restricted communities. This project will be a 62+ community. 138 residential parking and 10 visitor spaces.

Attorney Kathy Zickert stated that the Variance justification is because there is a Stream Buffer on 1 side of the property. Nature of population is 1 person

household. Kathy Zickert stated that she spoke with India Williams about her concerns with selling beer and alcohol in India Williams new establishment.

Leroy Calhoun 6812 Shannon Parkway stated that he was in agreement with his sister India Williams about concerns with selling beer and alcohol.
