A **Public Meeting** shall be held on the 30th day of August at 6:00 pm at City Hall, 5047 Union Street, Union City, before the Mayor and Council of the City of Union City at which time the Fiscal Year 2024 (September 1, 2023 through August 31, 2024) budget and millage rate shall be approved and the budget ordinance adopted in accordance with O.C.G.A. 36-81-5.
