On motion of Councilmember Owens-Twaites, seconded by Councilmember Hobbs, and carried, Council approved this item. Vote was unanimous, 4-0.



On motion of Councilmember Mealing, seconded by Mayor Pro Tem Jones, and carried, Council approved this item. Vote was unanimous, 4-0.


IV. ADJOURNMENT
