VII. RECOMMENDATIONS FROM THE PLANNING COMMISSION:

A **Public Hearing** to review an application by Matt Smith of Grady Health Systems to rezone an approximately 40.2 +/- acre tract of land from TCMU (Town Center Mixed Use with conditions) to TCMU (Town Center Mixed Use); to modify and amend the conditions and site plan from retail commercial to a proposed hospital. A **Public Hearing** to review an application by William Johnson of the MicroLife Institute to rezone a 1.915 +/- acre tract of land from GC (General Commercial) to RM (Multi-Family Residential) with a PUD (Planned Unit Development) overlay for a proposed 18-unit cottage court community. The property is located south of Cochran Rd and east of Stonewall Tell Road at 4807 Cochran Road, Union City, Georgia 30291. Planning and Zoning Commission recommends **approval with conditions.** Staff recommends **approval with conditions.** (Parcel ID 09F-2202-0100-116-0).
- C. A **Public Hearing** to review a city-initiated text amendment to amend Section 6-9 of Article VI of the Zoning Ordinance of Union City by adding "Data centers" as a conditional use in the O-I Office Institutional zoning district; and to amend Section 10-7 of Article X of the Zoning Ordinance of Union City by establishing parking requirements for "Data centers". Planning and Zoning Commission recommends **approval**. Staff recommends **approval**.
